The Board intends to obtain the services of a reputed PR agency to handle Public Relations activities in Germany, Japan, UAE, USA, Australia, UAE & Chile for a period of 2019-2021 years. The Cabinet Appointed Procurement Committee on behalf of the Sri Lanka Tea Board invites eligible agencies (hereinafter referred to as the bidders) registered with the Registrar of Companies, Sri Lanka, for the submission of bid proposal for the services described herewith. Interested bidder must provide information indicating that they are qualified to perform the services (description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Bidder may associate with overseas AOR (Agencies of Records) to enhance and strengthen their capacity.

**Tasks assigned**

- To develop the PR strategy related to promotion of Ceylon Tea in all above mentioned the six countries as per the technical guidelines given in the R.F.P.
- To propose the creative concepts for Public Relations campaign in those countries.
- To organize and implement creative PR events to promote Ceylon Tea image in all the six countries in parallel to Sri Lanka Tea Board advertising campaign.
- To organize publicity campaigns covering major media such as TV, Press and Social media in those six countries in parallel to Sri Lanka Tea Board advertising campaign.
- To propose methodology for monitoring and evaluation process.
