### **VOTING RIGHT**

KCCI members, who have completed at least two years of their valid membership of Karachi Chamber as on the date of announcement of the Election Schedule and have also renewed their membership by 31<sup>st</sup> March, 2018, will be eligible to cast vote.

#### **01) CIRCULATION OF ELECTION NOTICE, ISSUANCE OF PRELIMINARY VOTERS' LIST AND UP TO DATE ATTENDANCE LIST OF MC MEMBERS**

Circulation of Election Notice and up to date attendance list of Managing Committee members will be sent on Monday, 2<sup>nd</sup> July, 2018. A Preliminary Voters' list shall be provided to voters upon submission of a formal request, which can be collected from KCCI's R&I Section during office hours from Monday, 02<sup>nd</sup> July, 2018.

### **Eligibility to Cast Vote**


"Proprietor, Partner or Director of the Member Firm or Company or any representative not less than the rank of General Manager, authorized by the Board of Directors of Public Limited Company or a Multinational Company, shall be entitled to cast his/her vote at the time of election, only if his or her name has already been registered with the Secretary General and his name appears in voters' list."

The voter's signature at the time of casting vote, must tally with the Specimen Signature Card and Photograph of the voter already submitted at the Chamber.

- 02) **LAST DATE FOR RECEIVING CHANGES/OBJECTIONS FOR ENTRIES APPEARING IN PRELIMINARY VOTERS' LIST**  
The last date for receiving change(s) of authorized representative(s)/ objection(s) if any in the Preliminary voters list will be received on Thursday, 5<sup>th</sup> July 2018.
- 03) **INTIMATION BY SECRETARY GENERAL ON THE OBJECTION(S) OR CHANGE(S) SENT BY MEMBER(S).**  
The Secretary General will intimate action taken by him on Friday 6<sup>th</sup> July, 2018 in response to the objection(s) or change(s) sent by the member(s).
- 04) **DISPUTE(S) AGAINST THE DECISION(S) OF THE SECRETARY GENERAL TO BE REFERRED TO ELECTION COMMISSION**  
The Dispute(s) pertaining to eligibility of member(s) who is/ are aggrieved by the decision of the Secretary General received up to Saturday 7<sup>th</sup> July, 2018, would be referred to the Election Commission.
- 05) **MEETING OF THE ELECTION COMMISSION FOR REVIEWING/ DECIDING THE DISPUTE(S)**  
The meeting of the Election Commission for reviewing and deciding the dispute(s) pertaining to eligibility of member(s) aggrieved by the decision(s) of the Secretary General will be held on Monday 9<sup>th</sup> July, 2018.
- 06) **FINAL VOTERS' LIST**  
Final voters' list shall be displayed at the notice board or the conspicuous place of the office of the Chamber by Thursday 12<sup>th</sup> July, 2018, subject to incorporation of such changes, the Preliminary voters' list shall be deemed final voters' list who are eligible to cast vote for and contest as candidate in the elections.
- 07) **ISSUANCE & RECEIPT OF NOMINATION PAPERS FOR MANAGING COMMITTEE ELECTION**  
Nomination papers prescribed by the Chamber will be issued on request in writing and received daily during office hours with effect from Thursday 12<sup>th</sup> July, 2018.  
  
Candidate(s) contesting in the election for seat(s) of Managing Committee Member(s) shall be required to deposit Pay Order(s) of Rs. 15,000/- as Security Deposit in favor of Karachi Chamber of Commerce & Industry along with Nomination Paper(s). **The security deposit would be forfeited in the event of not securing at least 20% votes of total cast votes.**  
  
**PROPOSERS, SECONDRS AND CANDIDATES**  
Any person who is eligible to contest in the election for vacant posts, shall send his/her nomination to the Secretary General which must be duly proposed and seconded by a duly registered voter and signed by the candidate.
- 08) **LAST DATE FOR RECEIVING NOMINATION PAPER(S)**  
Last date for receiving Nomination paper(s) is Saturday 14<sup>th</sup> July, 2018.
- 09) **CIRCULATION OF FINAL VOTERS' LIST AMONG CANDIDATES**  
Final voters' list shall be provided to each contesting candidate on Tuesday 17<sup>th</sup> July, 2018.
- 10) **LIST OF CANDIDATES**  
List of candidates shall be displayed on Wednesday 18<sup>th</sup> July, 2018.
- 11) **LAST DATE OF RECEIVING OBJECTION(S) OVER NOMINATION OF THE CANDIDATES**  
The Election Commission will receive objection(s) if any over nomination of candidates till Thursday 19<sup>th</sup> July, 2018.
- 12) **ELECTION COMMISSION'S DECISION(S) ON NOMINATION(S)**  
The Election Commission will take decision(s) on objections raised over nomination of candidates on Friday 20<sup>th</sup> July, 2018.
- 13) **ISSUANCE OF THE FINAL LIST OF CANDIDATES**  
The Election Commission will circulate final list of candidates on Tuesday 24<sup>th</sup> July, 2018.
- 14) **LAST DATE FOR WITHDRAWAL OF NOMINATIONS**  
To avoid appearance of candidates' name on Ballot paper, the last date for withdrawal of nominations is Saturday 4<sup>th</sup> August, 2018.

- 15) **ISSUANCE OF AGENDA NOTICE FOR ANNUAL GENERAL MEETING**  
Agenda Notice for the Annual General Meeting will be circulated on Wednesday 5<sup>th</sup> September, 2018.
- 16) **MANAGING COMMITTEE ELECTION/ PRODUCTION OF CNIC OR CHAMBER'S IDENTITY CARD OR PASSPORT**  
(a) Managing Committee Members' Election will be held at KCCI on Saturday 22<sup>nd</sup> September, 2018.  
(b) The voters will have to produce original National Identity Card or Chamber's identity Card or Passport or any other mode of identification, whose number would be recorded on the counterfoil at the time of casting vote.
- 17) **ISSUANCE & RECEIPT OF NOMINATION PAPERS FOR OFFICE BEARERS' ELECTION**  
The issuance and receipt of nomination papers for Office Bearers' election will be carried out by the Election Commission on Monday 24<sup>th</sup> September, 2018.

The Election Commission will receive nominations for the election of Office Bearers till Tuesday 25<sup>th</sup> September, 2018.
- 19) **ISSUANCE OF LIST OF CANDIDATES FOR OFFICE BEARERS' ELECTION BY THE ELECTION COMMISSION**  
The Election Commission will issue the list of candidates contesting in the election of Office Bearers on Wednesday 26<sup>th</sup> September, 2018.

Election of the Office Bearers will be held on Thursday 27<sup>th</sup> September, 2018 at 4:00 PM in the Conference hall of the Chamber, Aiwani-e-Tijarat Road, Karachi. Conducted by Secretary General
